## **INVITATION TO BID**

## 1.0 RECEIPT OF BIDS

#### 2.0 DESCRIPTION OF WORK

All necessary labor, supervision, equipment, tools, and materials for: abandonment of the existing well, installation of a new alluvial well, expansion of the existing well house, installation of an iron and manganese treatment system, and connection to the sanitary sewer for the Well Improvements, and decommissioning of the existing cartridge filters, and UV disinfection system, installation of membrane filtration with Clean-in-Place (CIP) system, installation of waste tanks at the existing WTP site, and connection to the sanitary sewer for the WTP Improvements. Project includes installation of all required electrical conduit and wiring, panels, and control devices and related site work.
