#### 14. Reports

- a. Budget:
  - i. Easterseals was very appreciative of the donation and during March and April American Furniture Warehouse was matching funds for any donation, so we were able to help them get double the funds.
  - ii. Sales Tax: The law changed last year for charging sales tax, so for deliveries the tax is charged at the destination. This brought more sales tax revenue to the Town than expected.
- b. Mayor: (CCEDC, CDOT, CCFA)
  - i. The Town of Empire is looking for Town Residents to fill Two Volunteer Positions on the Empire Board of Trustees. Applicants must be a resident of Empire.
  - ii. We are planning on Codifying our Municipal Code. This means that we will take our Ordinances and put them all into one document, organized by subject. This will be a slow process. We are planning on starting with the Ordinances on Marijuana and the sections of Ordinance 170 dealing with Annexation.

#### c. Police:

- i. Chief Stein will provide a Monthly report with stats and updates.
- ii. Lyle Wohler's Law Enforcement Award for 2019, 2020. Luncheon is tomorrow, Wednesday May 26<sup>th</sup>.
- iii. Clear Creek County is in LEVEL CLEAR. Fully vaccinated people are no longer required to wear face masks in most settings, except where required by the State Orders, or by local businesses and workplaces. For those not yet vaccinated, State Officials and the Clear Creek County Public & Environmental Health Department suggest that face masks still be worn in indoor settings around others.
- iv. The Empire Police Department is planning to host National Night Out on Tuesday August 3<sup>rd</sup>. This event promotes police-community partnerships; crime, drug, and violence prevention; safety; and neighborhood unity.

### d. Admin:

- i. The Town Clerk would like to thank the members of the board for their involvement in current projects and events. Linda Robertson for being involved with the Garage Sale and Farmers Market, Lisa Kunze for being involved with the Surplus Equipment Inventory and Sale, and Michael Ellington for being involved with the Dog Park and Dog Waste Stations. Thank you to Wendy Koch for serving on Committees and Boards for CDOT, the Fire Authority, and Economic Development. Thank you to Denise Tennant for serving as the Ex Officio Board Member on the Planning Commission. Thank you to Chief John Stein for serving as Empire's Emergency Manager. Thank you to Officer Andrew Lorenz for coordinating Empire's first National Night Out Event. Thank you to Sally Rush for all her work on the Watershed Committees. I know everyone is busy, so the extra things you do are greatly appreciated!
- ii. Upcoming Events: We have a committee that is working on the Farmers Market. The Town Garage Sale is scheduled on June 5th and 6th, and the Town Clean-Up Day is scheduled on June 12<sup>th</sup> from 10 am 2 pm.

## e. Public Works: (Parks, Streets)

- i. The Town of Empire is hiring Public Works employees, FT, PT, and Seasonal. Must have valid CO DL, agree to background check and drug testing. Must be able to perform physical labor. Basic construction and plumbing knowledge preferred; small equipment operation helpful. Accepting applications until 6-30-21
- ii. The Public Works Department will flush the fire hydrants sometime in June. The Town does this every year to remove sediment from the water lines.
- iii. The Town will be planting flowers at the beginning of June. If you would like to donate and/or volunteer to help plant flowers in the Whiskey Barrels, please contact Town Hall. We will also turn on the sprinklers at that time.
- iv. The Town has closed the Dog Park during the month of May, which is done every year to allow the ground to rest. The Town is looking at options to improve the soil on a yearly basis. The Dog Park will re-open on Friday, May 28<sup>th</sup> for Memorial Day Weekend.
