9. **Announcement: Empire Board of Trustees Public Hearing for Well and Water Treatment Plant Improvements is on Thursday July 15<sup>th</sup>, 2021, at 6:30 pm.**

A public hearing will be conducted for informing citizens and soliciting public input, written or oral, regarding the Town of Empire Well & Water Treatment Improvements Project and Preliminary Engineering Report (PER). The PER is a report detailing the project consisting of proposed well improvements including a new drilled well and treatment, and improvements to the current slow sand filtration system. Total project costs are estimated at \$2.1 million. The report is being submitted to the Colorado Department of Public Health and Environment (CDPHE) to qualify the Town of Empire for a State Revolving Fund Loan. Copies of the

Preliminary Engineering Report are available for public review prior to the Public Hearing at Empire Town Hall or [www.TownOfEmpire.Colorado.Gov](http://www.TownOfEmpire.Colorado.Gov) .
