  - i. Michal Fagrelius Comment: (Her internet cut out and she did not hear the presentation) Concerned about the increase in water bills, not getting enough notice, why a large increase all at once, would like to see the data, wants to see communal billing and all residents paying the same rate.

#### Answer:

- Have not had large increases in cost until late in 2023, with most large increases in 2024.
- A chart of cost increases was presented during the meeting. An updated chart was presented to the Board at the December 3rd work session with the requested year by year breakdowns.
- Every residential unit, whether it is a house, a cabin or a mobile home is charged \$100/month for water/sewer fees. The mobile home parks pay the same into the system as a single family home owner.
- Board requested extra public input, but was not required.

ii. Rob Collins Comment: May need to increase estimates on the projects in the Budget, would like access to previous minutes.

#### Answer:

- Staff did increase project cost estimates for the 2025 budget and thank Rob for reminding the town of ever increasing maintenance and materials costs.
