TOWN OF EMPIRE, COLORADO
RESOLUTION 26-01

**A RESOLUTION OF THE BOARD OF TRUSTEES FOR THE TOWN OF EMPIRE,
COLORADO DETERMING THAT THE REGULAR MUNICIPAL ELECTION HELD
ON APRIL 7, 2026, SHALL BE A MAIL BALLOT ELECTION**

WHEREAS, pursuant to C.R.S. § 1-7.5-104, the Board of Trustees for the Town of Empire (the “Board”) may determine that certain elections may be conducted by mail ballot;

WHEREAS, in accordance with state law, the Town’s next election will be held on Tuesday, April 7, 2026 (the “2026 Municipal Election”);

WHEREAS, the Town of Empire (the “Town”) is permitted to conduct a mail ballot election on April 7, 2026 because the 2026 Municipal Election does not involve partisan candidates and will not be held in conjunction with a primary or congressional vacancy election; and

WHEREAS, at its regular meeting on February 3, 2026, the Board found that in the interest of increased voter participation, the 2026 Municipal Election shall be held by mail ballot.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF EMPIRE as follows:

Section 1. The above recitals are incorporated herein by reference.

Section 2. The Board has determined that the 2026 Municipal Election shall be by mail ballot. The Board hereby directs the Town Clerk, Alex Green, as the designated election official for the Town, to conduct the election by mail ballot in accordance with state law.

Section 3. The Town Clerk is hereby directed to take all such steps as are necessary to conduct the 2026 Municipal Election as a mail ballot election, including appointing election judges.

Section 4. This Resolution shall become effective immediately upon adoption.

RESOLUTION 26-02

**A RESOLUTION SUBMITTING TO THE REGISTERED ELECTORS OF THE TOWN
OF EMPIRE THE QUESTION OF ELIMINATING THE REQUIREMENT THAT
PAYMENTS OF BILLS AND STATEMENTS CONCERNING CONTRACTS AND
REBATES BE PUBLISHED**

WHEREAS, the Town of Empire (the "Town") is a statutory municipality organized under the laws of the State of Colorado; and

WHEREAS, C.R.S. Section 31-16-202 requires that the Town publish its proceedings related to the payment of bills and publish a statement concerning all awarded contracts and rebates allowed; and

WHEREAS, C.R.S. Section 31-16-202(1.5) provides that the requirement of publishing proceedings related to the payment of bills and a statement concerning all awarded contracts and rebates allowed may be waived if approved by the Town's electorate at a special or regular election; and

WHEREAS, the approval of a ballot issue which allows the Town to stop the publication of proceedings related to the payment of bills and publish a statement concerning all awarded contracts and rebates allowed will substantially reduce the costs and expenses of publication in full; and

WHEREAS, if the ballot issue is approved, the Town will post financial information on the Town's official website relating to payment of bills and statements concerning contracts; and

WHEREAS, the Board of Trustees for the Town of Empire deems it appropriate to submit a ballot question for the Ballot Issue to the electorate of the Town at the regular municipal election on April 7, 2026.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE
TOWN OF EMPIRE, COLORADO:**

Section 1. The following ballot question shall appear on the ballot at the regular Town election to be held on April 7, 2026:

Question 1. Shall the Town of Empire, Colorado be authorized to post financial information on the Town's official website relating to payment of bills and statements concerning contracts instead of publishing in accordance with CRS 31-20-202 substantially reducing the cost of publication?

Section 2. In connection with the fixing of the ballot title, the Board of Trustees of the Town of Empire finds and determines as follows:

- A. The Town Board of Trustees finds that the general understanding of the effect of a “yes” or “no” vote on the Ballot Issues will be clear to the electors.
- B. The ballot title for the Ballot Issues will not conflict with those titles selected for any other Town measure that will appear on the ballot at the April 7, 2026 regular Town election; and
- C. The ballot titles for the Ballot Issues correctly and fairly expresses the true intent and meaning of the measure.

Section 3 If Question #1 is approved, all Town bills shall be published on the Town’s website and a list of all contracts awarded and rebates approved by the Town involving the expenditure of more than thirty thousand dollars (\$30,000) per annum shall be posted on the Town’s website.

Section 4. The Town Clerk shall serve as the designated election official of the Town for purposes of performing acts required or permitted by law in connection with the election on the Ballot Question and shall take such action as may be required to comply with all applicable laws pertaining to the conduct of the election.

Andrew Ratliff – 53 West Park Avenue

(Resident + business owner on US-40)

Problems raised

- Ordinance affects ~two dozen properties that are mixed residential/commercial, including his.
- Needs on-street parking for:
 - Personal vehicle
 - Work truck and trailer
 - Employee vehicles
- Ordinance appears year-round, even though snow removal is a seasonal issue.
- Confusion about why parked vehicles are considered unsafe while new CDOT crosswalks extend into US-40, also narrowing the roadway.
- Snow-related parking restrictions have forced him to shift vehicles, creating parking conflicts with neighbors.

Suggestions

- Create a formal resident permit system allowing:
 - Business and personal vehicles
 - Parking directly adjacent to the owner's property
- Ensure permits apply in both residential and business districts.
- Install updated and consistent parking signage.
- Publish a clear list of available permits.

Eric Romine – 268 Park Avenue

(Primarily residential property)

Problems raised

- Parking rules are still unclear, even after discussion with code enforcement.
- Residents are unsure when parking in front of their own homes is allowed.
- Crosswalk placement has generated resident dissatisfaction.

Suggestions

- Implement a clear, structured permit process so residents know exactly what is allowed.
- Ensure residents can reliably park in front of their own homes without fear of violation.

Rob Collins – (Zoom participant)

Problems raised

- Lack of clarity on implementation timing:
 - When permits will be issued
 - When hang tags will be available
- Concern about accommodating guests and work-related visits without permits in hand.

Suggestions

- Expedite rollout of parking permits / hang tags, especially for:
 - Guests
 - Short-term visits related to work or property use

Mihalchicks – 38 West Mountain

(Short-term rental / Airbnb owners)

Problems raised

- Confusion about the 48-hour parking limit and when permits are required.
- Uncertainty about whether permits must be obtained every time guests stay.
- Concern about logistics and guest compliance, not immediate enforcement.

Suggestions

- Allow annual or reusable permits for short-term rental guests.
- Provide a clear system so Airbnb owners can:
 - Issue permits to guests
 - Avoid repeated permit requests for frequent turnovers

Additional Community Concerns (Unnamed / General Public Input)

Problems raised

- Requests for data-backed justification for:
 - Crosswalk placement
 - Parking restrictions
- Perception among some residents that:
 - Enforcement may be prioritized over resident needs
 - Town decisions feel driven by regulation or revenue rather than lived experience
- Safety concerns for:

- Children walking longer distances to cross US-40
- Elderly and disabled pedestrians navigating new crossings

Suggestions

- Request and share CDOT traffic and safety data publicly.
- Reevaluate crosswalk and parking impacts if evidence supports adjustments.
- Keep ordinance under ongoing review, with future public input.

ORDINANCE 277, SECTION 4, PARKING:

1. Parking on public streets in the residential zoning districts (R-1, R-2, R-3) is limited to forty-eight (48) consecutive hours in the same spot, unless otherwise posted, except under the following conditions:
 - 1.1 Personal vehicles may be parked on public streets directly adjacent to dwelling occupied by the owner of the vehicle. This exemption does not apply to R.V's, boats or trailers, and
 - 1.2 Guests of residents may be parked on public streets directly adjacent to dwelling occupied by the residents with parking permit issued by the Empire Police Department. Permits will not be issued for R.V's, boats or trailers.
2. Any vehicle left on a public street, not adjacent to the owner's house, for more than forty-eight (48) hours will be considered abandoned.
3. R.V's, boats and trailers will be considered abandoned if left on a public street more than 72 hours, even if the street is adjacent to the residence of the owner.
4. Parking on public streets in the residential-commercial zoning district (R-C) is limited to 2-hour parking, with no parking from 10 pm to 5 am, unless otherwise posted;
5. For a vehicle to be considered moved, it must be moved at least 100 feet from previous position.
6. Parking in public parking lots within the Town limits have the following restrictions, unless otherwise posted:
 - 6.1 Minton Park: Overnight parking and camping by paid permit only, and
 - 6.2 Theobald Park: Overnight parking by paid permit only, no camping, and
 - 6.3 Welcome Park: Overnight parking by paid permit only, no camping.
7. All vehicles cited for parking violations must be moved off all public streets within the Town limits.
8. Parking violations may be cited into the Empire Municipal Court.
9. Parking violation fees and parking permit fees may be set by Resolution.

TRAFFIC & PARKING

*Parking Fees (Updated 2025)

- All Parking Permits: All Permits will require a deposit of \$10.00 that will be refunded to the Permit holder when the physical permit is returned to the Town.
- Guest Parking Permits: Guests of residents will not be assessed a permit fee beyond the deposit.
- Parking Permits: Permits issued for extended parking, up to 5 nights, in all Town Parking lots are \$10.00 per night, plus the deposit.
- Camping Permits: Permits issued for overnight camping, up to 5 nights, only in Minton Park Parking lot are \$25.00 per night, plus the deposit.
- Semi-Truck Parking Permits: Permits issued for residents requiring overnight Semi-Truck parking in Residential Zoning Districts close to their residents are \$50.00 per year, requiring approval from the Empire Police Department.
